Mrs. Milch announced the Teachers of the Year: Jenna Buffett, Mary Ellen Guide, and Andrew Jacobs.

For the first time in history of the program--33 years--the ladies have tied for the Freedom Division championship. The team had to win three games on three consecutive days. They did what they had to do and ended the season with the co-championship. Baseball, like softball, defeated their first opponent in the state tournament, before bowing to the second round team. Boys' track had a 1-4 season, which included Abdul Bangor tying the school record in the high jump at 6'4". The Girls' track team went undefeated in the dual meet season, the first Riverside High School team to do so since the 1958-1959 basketball team. Along the way, the shuttle hurdle relay of Danish Hemingway, Cristina Martins, Venetia Hemingway, and Shannon Rossi reset the school record five times. All stars for the spring include: Softball team members Taylor Morgan, Amber Perlmutter, and Katelyn George made First Team Freedom. Jasmine Vasquez and Melissa Callahan were honored on the Second Team. Baseball team members Tim Bore made First Team Freedom and Dustin Cahill and Mark Moreno received Second Team honors. In Boys' Track, Sergio Portola made First Team Freedom for the hurdles and Abdul Bangor did the same as a Multi-Purpose Athlete. Abdul also made Second Team Freedom for the high jump and then came back to win the SJ Group I Championship in that event.
