## RIVERSIDE TOWNSHIP BOARD OF EDUCATION REGULAR MEETING April 5, 2023

The Regular Meeting of the Riverside Township Board of Education was held on Wednesday, April 5, 2023 at 7:04 p.m., in the Elementary Cafeteria.

Dr. Parker led the flag salute.

Mr. O'Brien announced that adequate notice of the meeting had been given to the public by notifying the Courier Post and the Burlington County Times and posting notice at the Riverside Town Hall on January 12, 2023.

Superintendent, Michael Adams, did a presentation on district happenings. Since the QSAC team knows it was not the fault of anyone currently here, they gave us the opportunity to rewrite all of our documents in order to regain those points on our evaluation. There were roughly 60 that needed to be rewritten to meet requirements. They gave us 28 (calendar) days.

First, thank you Ms. Saia for leading the process, pulling a team together, re-building the template to include the missing pieces, writing documents wherever necessary, and making all this happen.

Thank you Ms. Follis, Ms. Edmonds, Mr. Postell, and Mr. Gorelick for working on moving the existing curriculum into new template and filling in huge portions of the World Language, Science, and Visual and Performing Arts Curriculum.

Finally, a huge thank you to Erika Ruff, who finished her administrative internship on March 6<sup>th</sup>, but kept working and finalized almost 20 of the documents on her own, and then filling in wherever needed.

This was a group effort, even beyond these 6 individuals, as the other administrators that are here tonight took on extra responsibilities to help free them up.

Their work reminds us that we can do anything in Riverside if we work together."

On the motion by Ms. Pinho, seconded by Mrs. Koka, and carried unanimously, the meeting was adjourned at 8:00 p.m.
