Mr. O'Brien announced that adequate notice of the meeting had been given to the public by notifying the Courier Post and the Burlington County Times and posting notice at the Riverside Town Hall on January 13, 2022.

Mr. Adams announced Mr. Jackamonis as Vice Principal for the Middle School and discussed the background on that decision. He also gave an update about Sports Night, outcome of recent games, summer education programs, and senior plans after graduation and listed their majors. He also acknowledged Mrs. Bisch on being recognized and Mrs. Follis on her BCEA award.

GOOD NEWS

Mrs. Milch stated On June 8 at RHS Awards Night, two Riverside High School alumni will be honored as the Alumnus of the Year by the Riverside Education Association. Dr. Michael Rosenthal, Director of Family Medicine at Penn Medicine, will be recognized as the 2020 Alumnus of the Year. This should have happened two years ago, but COVID protocols prohibited us from honoring Dr. Rosenthal, a 1972 graduate. He will also represent all health care workers and first responders as the symbol of the 2021 Alumnus of the Year. In addition, Ron Gunkel, a 1985 graduate, will be honored as the 2022 Alumnus of the Year. Ron runs the non-profit group, Friends of Ron, which help hundreds, sometimes thousands of families each year. On April 26 the US Army completed their inspection of the JROTC. Conducted every three years, it is used to evaluate secondary educational institutions, JROTC instructors and to ensure compliance with program criteria. The Cadets performed a Continuous Improvement Project, a Service Learning Project, Cadet Portfolios, Cadet Drill and Color Guard inspections. The Cadets exceeded the standard in all events. Congratulations to the Cadets of the Ram Battalion for a job well done! In particular, Garry Edwards, Levy Martin, Cris Azevedo, Alexandra Siravo, and Ashley Ullaguari should be commended for their performance in leading the evaluation. Interact Club participated in the town-wide Egg Hunt, while the Fellowship of Christian Athletes ran the Pre-K Egg Hunt on April 14. Staff member Lea Lauletta received a STEM grant and will incorporate it into her business classes. Ninth grader Sydney Greenidge has set two freshman track records in the 400 intermediate hurdle event and the 200-meter event.
